## The specific role of the Committee would be to:

- (A) Advise, screen and examine the entire I.T. infrastructure and I.T. solution proposed for improved administrative efficiency in the department.
- (B) To advise on the manner of technical solutions, sizing, technical specifications, costings and price discovery methodologies including specific aspects of open source hardware and software based aspects.
- (C) To examine the technical viability and feasibility of any proposed I.T. application including web based and mobile phone application and need assessment thereof.
- (D) To evaluate pilot initiatives and projects in the application of I.T. in the Department of A.H. & Veterinary and Dairy Development Department.
- (E) The Committee shall be at liberty to create Technical Sub-committee which shall examine technical aspects referred by the State Level Committee and suggest suitable course of administrative action.

The recommendation of the Committee, its functioning and term shall be governed by standard administrative procedures in vogue in Government. Any member desirous of exiting or not undertaking any further responsibility as member is at liberty to submit a written communication to that effect, which shall be subject to decision thereof.
